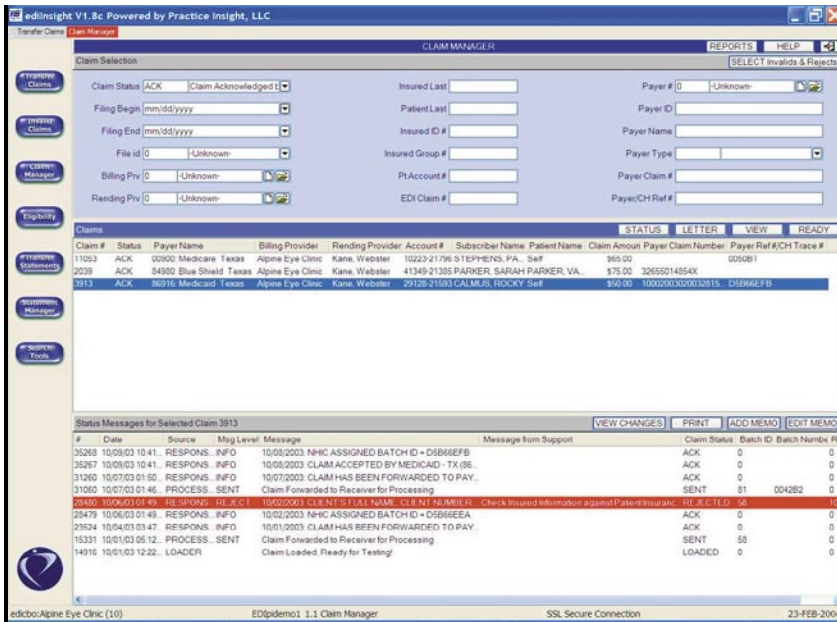

You will no longer need to worry about the status of a claim. Every related message from the claim clearinghouse or the payer is electronically attached to the claim thus eliminating the need for paper reports.

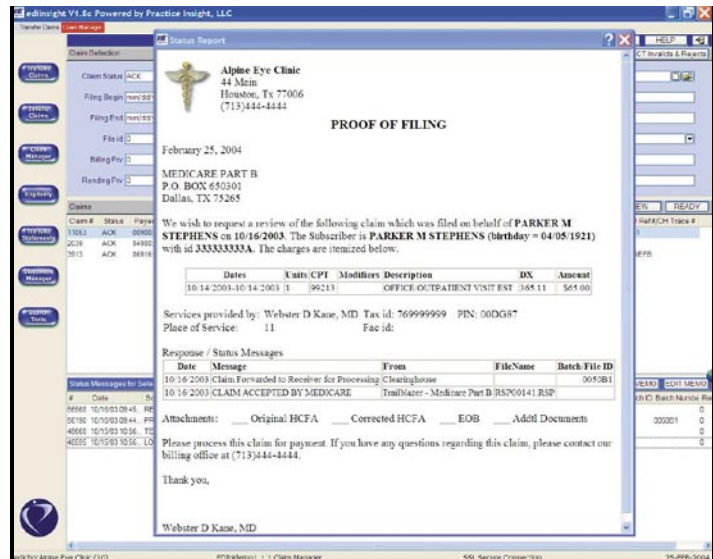
EDIinsight offers a suite of real-time electronic healthcare transactions including claims, claim status, eligibility and patient statements.
